Section 4 First Aid

EMERGENCY OVERVIEW

DANGER. May be harmful if swallowed. Causes severe skin burns and eye damage. May cause respiratory irritation.

EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. Immediately call a poison center or a physician.

Primary Route of Entry: Skin contact, eye contact, inhalation
